John Elliot DEAN, UCONN SCHOOL OF BUSINESS 2022 may well be remembered as the year we all took a deep breath and pushed on ahead. **Small businesses** worked through the residual challenges of the pandemic and moved cautiously in the face of rising inflation and uncertain growth outlook. Despite these obstacles, it was a year of progress and resilience. As a testament to our impact, we provided 12,866 hours of advisory services, assisting 3,330 clients and contributing to the creation of 536 jobs. Additionally, our team played a vital role in launching 191 new businesses and facilitated an impressive \$87 million in debt and equity investments. The dedication and expertise of our business advisors were recognized, with 97% of surveyed clients expressing satisfaction with their guidance.

CTSBDC achieved re-accreditation following a thorough review of Baldwin Quality Standards, marking a significant milestone, while also being **selected as the Lead Technical Assistance provider for the Connecticut Small Business Boost Loan program**, collaborating closely with DECD and the National Development Council.

CTSBDC recognizes that the **strong support from various organizations**, **agencies**, **businesses**, **individuals**, as well as our **host institution**, **funders**, **community partners**, **and resilient entrepreneurs**, is essential for enabling our clients' success and maximizing our impact in supporting small businesses and communities.

CTSBDC remains an important component of UConn's engagement with the community. We at the UConn School of Business recognize the importance of supporting our state's small businesses and nascent entrepreneurs. 

Connecticut Small Business Development Center doesn't just serve small businesses, it strives to help others, including public agencies, who assist, regulate, and register them. **CTSBDC responded to hundreds of referrals from the following state agencies:** the Department of Economic and Community Development, the Department of Revenue Services, the Secretary of State's office, CI/CTNext, the Department of Developmental Services, the Department of Labor, and the Department of Consumer Protection.


CTSBDC's pre-venture advisors have a strong working relationship with the staff at the Secretary of State's office and the Department of Revenue Services, which yields positive results for clients. CTSBDC is also building a relationship with AdvanceCT, the state's quasi-economic development agency, which provided 69 referrals to the program.





CTSBDC's 17 advisors have wide-ranging expertise and deep experience covering areas such as **small business lending, launching a business, technology innovation, exporting, market strategy, and more.** As part of their professional development, in 2022 advisors **attended 1,168 professional development events totaling 1,575 hours of training.** Advisors are organized into 3 teams, each with at least one **specialists in launching a business, accessing capital, acquiring customers, and improving operations and processes.**

CTSBDC launched its Minority Business Growth Program (MBGP), with financial support from Santander Bank and the UConn School of Business. **The eight three-hour session program ran twice and attracted 20 participants** who received technical knowledge and access to resources that helped their businesses scale and thrive. Participants also engaged in facilitated discussions and had the opportunity to network.

In-Home Angels JO-BETH FOLEY OWNER Michael D'Amato and John Guszkowski co-founded Tyche Planning & Policy Group to help rural and small communities develop plans and processes focused on the bottom line of sustainability. Tyche's mission is to "create great communities for all" by providing assistance to towns on a schedule and budget that works for them and offering an expert team of land use and policy professionals.

CTSBDC Advisor Tammy Eldredge helped Michael and John launch their business, which created 4 full-time and 1 part-time jobs. In addition, Tyche benefited from the Verge Consulting Program at UConn where graduate students helped them in the development of a strategic plan.

In-Home Angels was founded based on a genuine desire to provide safe, quality, and compassionate care to those in need. In-Home Angels provides care for the elderly, cancer patients, and adults with disabilities through customized care plans run by trained and insured caregivers.

CTSBDC Advisor Valerian Gomez helped JoBeth navigate the challenges of her business model and access to funding opportunities. As a result, In-Home Angels has created 36 jobs, secured \$135,000 in funding, and grew revenues by \$200,000. WENDY WARD OWNER Angelique Kuang, a former middle school teacher, always struggled with the limitations of mentoring students. Led by her passion for children, she started a franchise of BusinessKids in Connecticut. BusinessKids is a Mexican company that offers an online children's entrepreneurship program. Through active games and real-life scenarios, children are introduced to the world of business and encouraged to start their own businesses after the four-month online training.

Angelique contacted CTSBDC in order to receive guidance on starting her business. She worked with Business Advisor Nelson Merchan, who provided the support and resources needed to start BusinessKids successfully.

Wendy Ward launched her business, futuresThrive, on Sept. 2019. Wendy's main product is a clinically backed AI screening device that detects the warning signs of mental health concerns in the form of a game that can be administered by a pediatrician.

CTSBDC Advisor Christine Sullivan advised Wendy on strategy and tactics that helped futuresThrive secure an SBIR Phase 1 Grant. Christine continues to assist Wendy with her efforts to bring her technology to the health industry and looks forward to seeing how futuresTHRIVE "continues developing this impactful solution to pediatric mental health through an accessible and affordable technology-driven product." STUDENT PROGRAM

The Santander Bank Student Program is an internship program sponsored by *Santander Bank* that **provides undergraduate UConn students with meaningful career-related internship experience working with small businesses at CTSBDC.** In 2022, CTSBDC hired **13 students who worked with 15 clients** in a variety of areas, including digital marketing, finance, and market research.



AMERICAS BDC CT SMALL BUSINESS BOOST FUND

Supported by the Connecticut Department of Economic & Community Development and operated by the National Development Corporation, the fund links small business owners to the financial support they need to thrive.
